TERMS AND CONDITIONS

- Customer agrees to pay \$______ (base fee) for the ______ yard container which includes up to______ tons of material as well as any overages incurred due to overloading or additional days requested by the Customer. The containers include up to ______ tons; however, due to strict weight limitations and associated dump fees, any additional materials will be billed at \$______ per ton above ______ tons.
- 2. Customer is responsible for any additional fees assessed by the landfill.
- 3. The container rental includes use for up to _____days. If the container is kept longer then _____ days, there will be an additional fee of \$60.00 per week.
- 4. Payment for all base fees as well as any known additional rental time will be due upon delivery of the container. Any additional fees due to overweight or other fees not paid upon deliver are due within 14 days of container pick up.
- 5. Any unpaid balance after 14 days will start to accrue 15% interest from the date of container pick up until paid in full. There will be a minimum of a \$25.00 late fee.
- 6. If paying by check and the check is returned for insufficient funds from the banking institution, the Customer is responsible for any returned check fees.
- Items placed in roll-off <u>cannot</u> exceed the maximum fill line. If contents exceed and we cannot collect, YOU
 WILL BE CHARGED A TRIP FEE. You will be responsible for removing contents prior to our return.

DUMPSTER USE

- 1. While refuse dumpsters are in your possession, you will **NOT** place or allow to be placed into the dumpster the following.
 - A. Substances hazardous to health such as toxic or corrosive materials or liquids.
 - B. Liquids of any kind whether contained or not.
 - C. Cans, drums, or other container of any kind unless emptied and crushed and incapable of carrying any liquid
 - D. Medical waste or animal carcasses of any kind
 - E. Any material not listed above however considered unsuitable for containment e.g. malodorous waste, asbestos, paint, tires, gas bottles, fluorescent tubes, light bulbs, vehicle batteries, household appliances such as but not limited to refrigerators, conventional ovens, microwaves, washer and dryers.
 - F. Extremely heavy material such as rock, dirt, or concrete.
- 2. All refuse shall remain within the confines of the dumpster and shall not exceed the top or sides. Every attempt shall be taken to equally disperse the weight of the refuse within the dumpster.
- 3. Customer shall be liable for any loss or damage to rented equipment more than reasonable wear and tear. Initial that you have read these terms and understand; ______ Date______ Date______

ACCESS AND GROUND CONDITIONS

- 1. The customer will be responsible for free and suitable access to and from the delivery site (including the removal of local obstructions) and for ensuring suitable ground conditions for delivery, placement, and removal of the dumpster. No responsibility will be accepted for the damage to any surface. You should therefore take steps to protect surfaces (e.g. paving, slabs, soft ground) before delivery.
- 2. Should the container cause damage to concrete, asphalt, or ground during loading or unloading, Gettysburg Landscape Yard is only responsible if this is due to our negligence. We have specifically identified that the heavy container may cause damage and that of placement of these heavy containers are the customer's responsibility to secure a location for them.
- 3. Should the Customer fail to return the container, Gettysburg Landscape Yard maintains the right to enter upon the premises where the container may be without notice and take possession of and remove it a the Customer's expense all without legal process, the customer hereby waving any claims for damages from any such entry or removal.
